

1. I, Sudeshkumar V. 
- ii. The Members of the Company as on the "cut-off" date i.e. 21st September, 2016, were entitled to vote on the Resolutions (items No. 1 to 3 as set out in the Notice of the 25th AGM of the Company).
- iii. After the time fixed for closing of the poll by the Chairman, 1 (One) ballot box kept for polling was locked in my presence with due identification marks placed by me.
- iv. The locked ballot box was subsequently opened in my presence and poll papers were diligently scrutinized. The poll papers were reconciled with the records maintained by the Company/ Registrar and Transfer Agents of the Company and the authorizations/ proxies lodged with the Company.
- v. The poll papers, which were incomplete and/or which were otherwise found defective have been treated as invalid and kept separately.
- vi. Thereafter, the electronic votes cast through remote e-voting were unblocked at 11.05 a.m. i.e. after the Conclusion of 25th Annual General Meeting in the presence of 2 witnesses Mr. Ajay Mehta (ACS - 9332), Practicing Company Secretary and Mr. Akshay Joshi (ACS - 34724) who are not in the employment of the Company.

It contained the particulars of name, address, folio number or client ID of the shareholders, number of shares held by them, nominal value of such shares. There were no shares with differential voting rights in the Company; hence there is no requirement of maintaining of the list of shares with differential voting rights.



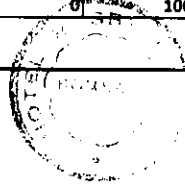
